# The Social Security (Up-rating) (Miscellaneous Amendments) (Scotland) Regulations 2025

*Made - - - - 28th March 2025* 

Coming into force in accordance with regulation 1

The Scottish Ministers make the following Regulations in exercise of the powers conferred by section 13(1) of the Social Security Act 1988(a), section 70(8) of the Social Security Contributions and Benefits Act 1992(b), sections 28(2), 30(2), 31(2), 32(2), 34(2), 79(1) and 95 of the Social Security (Scotland) Act 2018(c) and all other powers enabling them to do so.

In accordance with section 13(2) of the Social Security Act 1988, they have consulted with the Welsh Ministers( $\mathbf{d}$ ).

In accordance with section 97(2) of the Social Security (Scotland) Act 2018, the Scottish Ministers have informed the Scottish Commission on Social Security of their proposals, notified the Scottish Parliament that they have done so and made their proposals publicly available by such means as they consider appropriate.

In accordance with section 96(2) of the Social Security (Scotland) Act 2018(e), a draft of this instrument has been laid before and approved by resolution of the Scottish Parliament.

#### Citation, commencement and interpretation

- **1.**—(1) These Regulations may be cited as the Social Security (Up-rating) (Miscellaneous Amendments) (Scotland) Regulations 2025.
- (2) Subject to paragraphs (3), (4), (5) and (6) these Regulations come into force on 31 March 2025.
  - (3) Regulations 3, 4, 5, 6, 7, 8, 12 and 15 come into force on 1 April 2025.
  - (4) Regulation 13 comes into force on 6 April 2025.
  - (5) Regulations 9, 10, 11, 14 and 16 come into effect on 7 April 2025.
  - (6) Regulation 2 comes into effect on 9 April 2025.

# Saving and transitional provisions

### **Best Start Grants Regulations**

- 1.—(1) This paragraph applies where an individual's application for assistance was made on or after 1 April 2024 and before 1 April 2025.
- (2) Despite regulation 3, paragraphs 6 and 7 of schedule 2 of the Best Start Grants Regulations continue to have effect on and after 1 April 2025 as they did immediately before that date for the purpose of determining the amount of assistance to which the individual is entitled.
- (3) Despite regulation 3, paragraph 4 of schedule 3 and paragraph 5 of schedule 4 of the Best Start Grants Regulations continue to have effect on and after 1 April 2025 as they did immediately before that date for the purpose of determining the value of assistance to which the individual is entitled.

## **Best Start Foods Regulations**

- **2.**—(1) This paragraph applies where an individual's entitlement to benefit includes an award for the period on or after 1 April 2024 and before 1 April 2025.
- (1) Despite regulation 4, regulation 10 of the Best Start Foods Regulations continues to have effect on and after 1 April 2025 as it did immediately before that date in respect of the period mention in sub-paragraph (1).

## **Funeral Support Payment Regulations**

- **3.**—(1) This paragraph applies where an individual's application for assistance was made on or after 1 April 2024 and before 1 April 2025.
- (2) Despite regulation 5, regulation 13 of the Funeral Support Payment Regulations continues to have effect on and after 1 April 2025 as it did immediately before that date for the purpose of determining the amount of assistance to which the individual is entitled.

#### **Young Carer Grants Regulations**

- **4.**—(1) This paragraph applies where an individual's application for assistance was made on or after 1 April 2024 and before 1 April 2025.
- (1) Despite regulation 6, regulation 12 of the Young Carer Grants Regulations continues to have effect on and after 1 April 2025 as it did immediately before that date for the purpose of determining the amount of assistance to which the individual is entitled.

## **Child Winter Heating Payment Regulations**

- **5.**—(1) This paragraph applies where an individual is entitled to be paid child winter heating assistance in respect of a qualifying week occurring on or after 1 April 2024 and before 1 April 2025.
- (2) Despite regulation 7, regulation 10 of the Child Winter Heating Payment Regulations continues to have effect on and after 1 April 2025 as it did immediately before that date for the purpose of determining the value of assistance to which the individual is entitled in respect of the qualifying week mentioned in sub-paragraph (1).
- (3) In this paragraph, "child winter heating assistance" and "qualifying week" have the meanings given in regulation 2 of the Child Winter Heating Payment Regulations.

#### **Scottish Child Payment Regulations**

- **6.**—(1) This paragraph applies where part of an individual's determination of entitlement includes an award for the period on or after 1 April 2024 and before 1 April 2025.
- (2) Despite regulation 8, regulation 20(1) of the Scottish Child Payment Regulations continues to have effect on and after 1 April 2025 as it did immediately before that date in respect of the period mentioned in sub-paragraph (1).

## **Child Disability Payment Regulations**

- 7.—(1) This paragraph applies where an individual's determination of entitlement includes an award for the period on or after 8 April 2024 and before 7 April 2025.
- (2) Despite regulation 9, regulation 23 of the Child Disability Payment Regulations continues to have effect on and after 7 April 2025 as it did immediately before that date in respect of the period mentioned in sub-paragraph (1).

## **Adult Disability Payment Regulations**

- **8.**—(1) This paragraph applies where an individual's determination of entitlement includes an award for the period on or after 8 April 2024 and before 7 April 2025.
- (2) Despite regulation 10, regulation 34 of the Adult Disability Payment Regulations continues to have effect on and after 7 April 2025 as it did immediately before that date in respect of the period mentioned in sub-paragraph (1).

## **Adult Disability Payment Transitional Regulations**

- **9.**—(1) This paragraph applies where an individual's determination of entitlement includes an award for the period on or after 8 April 2024 and before 7 April 2025.
  - (2) Despite regulation 11, regulation 6 of the Adult Disability Payment Transitional Regulations continues to have effect on and after 7 April 2025 as it did immediately before that date in respect of the period mentioned in sub-paragraph (1).

## **Winter Heating Payment Regulations**

- 10.—(1) This paragraph applies where an individual is entitled to be paid winter heating payment in respect of a qualifying week occurring on or after 1 April 2024 and before 1 April 2025.
- (2) Despite regulation 12, regulation 9 of the Winter Heating Payment Regulations continues to have effect on and after 1 April 2025 as it did immediately before that date for the purpose of determining the value of assistance to which the individual is entitled in respect of the qualifying week mentioned in sub-paragraph (1).
- (3) In this paragraph, "winter heating payment" and "qualifying week" have the meanings given in regulation 2 of the Winter Heating Payment Regulations.

## **Carer Support Payment Regulations**

- 11.—(1) This paragraph applies where an individual's application for assistance was made on or after 7 April 2024 and before 6 April 2025.
- (2) Despite regulation 13, regulations 14(1) and 16(1) of the Carer Support Payment Regulations continue to have effect on and after 6 April 2025 as they did immediately before that date in respect of the period mentioned in sub-paragraph (1).

## **Pension Age Disability Payment Regulations**

- **12.**—(1) This paragraph applies where an individual's application for assistance was made on or after 21 October 2024 and before 7 April 2025.
- (2) Despite regulation 14, regulation 26 of the Pension Age Disability Payment Regulations continues to have effect on and after 7 April 2025 as it did immediately before that date for the purpose of determining the amount of assistance to which the individual is entitled.

# **Pension Age Winter Heating Payment Regulations**

- 13.—(1) This paragraph applies where an individual's application for assistance was made on or after 20 November 2024 and before 1 April 2025.
- (2) Despite regulation 15, regulation 10 of the Pension Age Winger Heating Payment Regulations continues to have effect on and after 1 April 2025 as it did immediately before that date for the purpose of determining the amount of assistance to which the individual is entitled.

## **Scottish Adult Disability Living Allowance Regulations**

- **14.**—(1) This paragraph applies where an individual's application for assistance was made on or after 21 March 2025 and before 7 April 2025.
- (2) Despite regulation 16, regulation 29 of the Scottish Adult Disability Living Allowance Regulations continues to have effect on and after 7 April 2025 as it did immediately before that date for the purpose of determining the amount of assistance to which the individual is entitled.

#### **EXPLANATORY NOTE**

(This note is not part of the Regulations)

These Regulations provide for an increase in various values and amounts of forms of assistance payable by virtue of regulations made under the Social Security (Scotland) Act 2018 and make amendments to the Social Security (Invalid Care Allowance) Regulations 1976, and the Welfare Foods (Best Start Foods) (Scotland) Regulations 2019. The Regulations come into force on 31 March 2025 with the exception of regulations 3, 4, 5, 6, 7, 8, 12 and 15 which come into force on 1 April 2025, regulation 13 which comes into force on 6 April 2025, regulations 9, 10, 11, 14 and 16 which come into effect on 7 April 2025 and regulation 2 which comes into effect on 9 April 2025.

Regulation 2 amends regulation 8 of the Social Security (Invalid Care Allowance) Regulations 1976 ("the 1976 Regulations") to increase the amount that a person eligible for payment of carer's allowance from the Scottish Ministers can earn in a given week without being deemed to be gainfully employed and, therefore, losing their entitlement to carer's allowance. The Social Security Amendment (Carer's Allowance) Regulations 2002 replaces references to "Invalid Care Allowance" with references to "Carer's Allowance" in certain legislative provisions, but "Invalid Care Allowance" remains part of the title of the 1976 Regulations for statutory purposes.

Regulation 3 increases the amount of the pregnancy and baby grant payable under the Early Years Assistance (Best Start Grants) (Scotland) Regulations 2018. Regulation 3 also increases the value of the early learning grant and the school-age grant, payable under those Regulations. Paragraph 1 of the schedule makes saving provision so that the previous values or amount of this assistance are still payable in certain circumstances

Regulation 4 increases the value of the basic rate of Best Start Foods benefit under the Welfare Foods (Best Start Foods) (Scotland) Regulations 2019. Paragraph 2 of the schedule make transitional provision so that the previous values of this assistance are still payable in certain circumstances.

Regulation 5 increases the amounts of funeral expense assistance payable under the Funeral Expense Assistance (Scotland) Regulations 2019. Paragraph 3 of the schedule makes saving provision so that the previous amounts of this assistance are still payable in certain circumstances.

Regulation 6 increases the amount of Young Carer Grant payable under the Carer's Assistance (Young Carer Grants) (Scotland) Regulations 2019. Paragraph 4 of the schedule makes saving provision so that the previous value of this grant is still payable in certain circumstances.

Regulation 7 increases the value of child winter heating payment payable under the Winter Heating Assistance for Children and Young People (Scotland) Regulations 2020. Paragraph 5 of the schedule makes saving provision so that the previous value of this assistance is still payable in certain circumstances.

Regulation 8 increases the value of Scottish Child Payment payable under the Scottish Child Payment Regulations 2020. Paragraph 6 of the schedule makes saving provision so that the previous value of this assistance is still payable in certain circumstances.

Regulation 9 increases the amount of Child Disability Payment payable under the Disability Assistance for Children and Young People (Scotland) Regulations 2021. Paragraph 7 of the schedule makes saving provision so that the previous amount of this assistance is still payable in certain circumstances.

Regulation 10 increases the amount of Adult Disability Payment payable under the Disability Assistance for Working Age People (Scotland) Regulations 2022. Paragraph 8 of the schedule makes saving provision so that the previous amount of this assistance is still payable in certain circumstances.

Regulation 11 increases the amount of a transitional rate of Adult Disability Payment payable under the Disability Assistance for Working Age People (Transitional Provisions and Miscellaneous Amendment) (Scotland) Regulations 2022. Paragraph 9 of the schedule makes

saving provision so that the previous amount of this assistance is still payable in certain circumstances.

Regulation 12 increases the value of winter heating payment payable under the Winter Heating Assistance (Low Income) (Scotland) Regulations 2023. Paragraph 10 of the schedule makes saving provision so that the previous value of this assistance is still payable in certain circumstances.

Regulation 13 amends regulation 14 of the Carer's Assistance (Carer Support Payment) (Scotland) Regulations 2023 (the Carer Support Payment Regulations) to increase the earnings limit for payment of carer support payment. Regulation 13 also increases the amount of carer support payment payable under regulation 16 of the Carer Support Payment Regulations. Paragraph 11 of the schedule makes saving provision so that the previous amount of this assistance is still payable in certain circumstances. Regulation 13(3) also amends schedule 2 (calculation of earnings) of the Carer Support Payment Regulations so that any remuneration paid to the individual in respect of neonatal care leave is treated as earnings for assessing entitlement to Carer Support Payment.

Regulation 14 amends regulation 26 of the Disability Assistance for Older People (Scotland) Regulations 2024 (the Pension Age Disability Payment Regulations) to increase the amount of Pension Age Disability Payment. Paragraph 12 of the schedule makes saving provision so that the previous value of this assistance is still payable in certain circumstances.

Regulation 15 amends regulation 10 of The Winter Assistance (Pension Age) (Scotland) Regulations 2024 (the Pension Age Winter Heating Payment Regulations) to increase the amount of Pension Age Winter Heating Payment. Paragraph 13 of the schedule makes saving provision so that the previous value of this assistance is still payable in certain circumstances.

Regulation 16 amends regulation 29 of The Disability Assistance (Scottish Adult Disability Living Allowance) Regulations 2025 (the Scottish Adult Disability Living Allowance Regulations) to increase the amount of Scottish Adult Disability Living Allowance payment. Paragraph 14 of the schedule makes saving provision so that the previous value of this assistance is still payable in certain circumstances.
